#### **Welcome to New Board Members**

We are proud to welcome new Family & Children's Service of Ithaca Board Members:



**Nadia Rubaii, PhD**, is a Professor of Public Administration and Co-Director of the Institute for Genocide and Mass Atrocity Prevention at Binghamton University. She has over 30 years of experience teaching graduate courses and professional workshops on all aspects of human resource management. Omar is also the President of the Iota Iota Lambda Chapter of Alpha Phi Alpha Fraternity Incorporated—the first historically African American intercollegiate Greek-lettered fraternity (founded in Ithaca, in 1906), whose mission is to develop leaders, promote brotherhood and academic excellence, while providing service and advocacy for the community. Omar is honored to serve and to advocate for the Ithaca Community in both a professional and personal capacity. He looks forward to working with the Board to ensure that F&CS continues to provide high quality service to our community.

## 2020 Community Awards

One of the most special parts of our Annual Meeting is celebrating the work and achievements of community partners and volunteers who go above and beyond to serve our community.

The Family & Children's Service Family Partner Award is given annually, in recognition of a business or corporation that has made a significant contribution to F&CS, and to our community.



This year's Family Partner Award is presented to CFCU Community

**Credit Union** for their long history of supporting F&CS through program and event sponsorship, and for their dedication to our community through the Credit Union's continued philanthropic efforts. CFCU has sponsored numerous programs at F&CS, including the Grandparents and Caregivers Support Group, the Open Doors program for runaway and homeless youth, and in 2019, CFCU became the lead sponsor on F&CS's inaugural Cardboard Boat Race. In 2019 alone, CFCU Community Credit Union staff supported 130 local nonprofits, offered 4,185 volunteer hours, held 30 Jeans Days, each supporting a different nonprofit, and raised more than \$75,000 for local nonprofits. The Family & Children's Service Agda Osborn Award is given annually in recognition of an individual or community organizer who has, in the judgement of the Board of Directors, made outstanding contributions to the community through exemplary community service and volunteerism.



This year's **Agda Osborn Award** is presented to **Cal Walker**.

An Alabama native, Cal Walker has lived in Ithaca for over forty years. He

worked for Cornell University for 25 years in Student & Academic Services, and as Outreach Liaison in Community Relations. Now retired, he is a social entrepreneur actively pursuing various interests.

He was a co-founder of the Village at Ithaca whose mission is to advocate for excellence and equity in Ithaca's public schools, by developing strategic community relationships, programs, and services to ensure that all students, particularly Black, Latino/a, low income, and other underserved students, consistently meet or exceed local and New York State standards of achievement. The organization has been recognized locally and statewide for its work in expanding educational opportunity, increasing access and furthering the cause of social justice in the community.

Cal has also served as a deacon at his church for nearly 30 years, taught in the county jail and has been an Alternative Instructor in the local school district since 1993. He has served on numerous boards and advisory committees supporting the work of local non-profit organizations.

Cal and his wife Glenda have four biological children, six grandchildren and, over the past 20 years, have welcomed 52 other children into their home as foster parents.

volunteers, that through exceptional volunteerism have demonstrated devotion and commitment to advancing the mission of Family and Children's Service of Ithaca; and through the volunteerism, long-lasting impacts have been realized at Family and Children's Service of Ithaca.



This year's **Sandy True Award for Exceptional Volunteerism** is presented to **Andrea Mooney**.

Andrea Mooney is a clinical professor of Law at the Cornell Law School with an extensive career in teaching and child advocacy. She has worked at the Law Guardian Office of Citizens Concerned for Children, in Tompkins County (representing children in Family Court), where she has worked closely with F&CS therapists to protect and serve the interests of her clients. She is a Project Counsel for Cayuga County Safe Schools/Healthy Students Partnership. Andrea has worked with F&CS in many capacities for nearly thirty years, including running the Home Care Program from 1978-82. She served on the F&CS Board of Directors from 2010-2017, and as Board Chair from 2015-2016, as well as serving on several other non-profit boards in our community. Andrea continues to serve on F&CS's Incident Review Committee as a community member. Over the years, she has donated countless pro-bono hours of legal consultation and support to help maintain the highest level of confidentiality for F&CS clients, and has provided essential guidance in regards to legal issues in family court.
